

## Pre-Authorized Debit (PAD) Agreement

I authorize BriarPatch Family Life Education Centre and the financial institution designated to begin deductions as per my instructions for monthly regular recurring school fees, to be debited the 1st of each month or the next business day. This authority is to remain in effect through the duration of the indicated school year only or until written notification is sent from me for earlier cancellation to BriarPatch Family Life Education Centre requesting termination of the Agreement. I understand that any modifications to account information (including cancellation) requires ten (10) business days written notice before the next PAD is due. Please visit your financial institution for more information regarding your rights and responsibilities when paying your fees using the Pre-Authorized Debit Plan.

Important: A "VOID" cheque, or an equivalent bank-issued PAD document must be returned along with this completed agreement.
